- Addition of Andrew Hampton to the Gov Committee
 - Andrew has accepted the invitation to the Governance Committee, add to email lists and add to meeting scheduling.
- Strategic Framework status: the framework is almost fully done, but there are some outstanding comments about our ability to streamline policy and permitting streamlining in actionable ways.
 - Anna mentions most signatories cannot formally support specific policy, so we may not be the best people to streamline policy, however permitting is something we may be able to support.
 - Bob agrees on the policy part, the one policy element that could be do-able is signatories that CAN sending letters of support to do so when things so pop up.
 - Bob says we have a lot of expedited options for permitting options.
 - Sandi mentions that there are routine updates to what bills are coming through that are relevant to fish passage at CalTrout, possibly doing that for the Forum getting that into a memo.
 - Sandi mentions we have informed policy in the past. Jump test is a good example, another project was examining fishways for effectiveness with the hope of changing policy on fishway implementation, never got traciton.
