Reminder of Holly maternity leave and general plan for committee work while I am away

This is Holly's last P&P meeting before heading on maternity leave. Grace Adams, gadams@nrccorp.com will be facilitating in her absence. Anna as committee chair will work with Grace to get committee agendas out and keep committee work going.

Discussion of scope of permitting case studies

The committee discussed the scope and goals of the permitting case studies. The goals, in order of priority of publishing these case studies are:

- 1. Communicating what has worked well re. simplified permitting pathways within individual interviews.
- 2. Communicating challenges encountered within individual interviews.
- 3. Exploring where consistent challenges exist in broader document which include common themes identified from previous interviews.

Ideally, case studies strike a balance between communicating information which is broad enough to apply to many practitioners, but specific enough to be more useful than common knowledge. The committee also discussed how sometimes the most interesting details of a project come from site conditions or constraints. The interviews may naturally touch on those and how those effect the implementation of the project (including getting the permits). Two examples are:

Strawberry Creek at Clam Beach-Trout Unlimited.

Details of that project that influenced getting permits were related to timing of poured concrete curing, and when to rewater the channel. Agencies had input on concrete curing times- interesting!

Santa Margarita Bridge- California Trout

This project is navigating a condition of the USFWS BO that includes holding a conservation easement for the area. This is complicated by the size of the project and the number of partners involved. It would be interesting to learn if other projects deal with this, who carries the easement, how its priced, etc. The committee mentions that this may be an uncommon case, since this doesn't seem to be part of a programmatic BO, maybe more a condition of the regional office handling the project.

The committee may decide to develop case studies about outlying situations as they are deemed relevant, but for now we are going to stick with case studies that meet the numbered goals above.

An example of a common theme independent of any project is the inconsistency with agency personnel interpretation of permitting compliance. Sustainable Conservation touched on this in their White Paper "Accelerating Restoration in the Sacramento Valley and Beyond: Progress and Next Steps to Cut Green Tape in California." Where one of their recommendations included agencies providing policy recommendations and direction to regional and local staff to reduce inconsistency.

Schedule next interviews for permitting case studies

Anna will consider who else from the TU team would be good to have on the interviews for Noyo, No Name Gulch and (perhaps separately, Strawberry Creek). Anna will talk with her project managers and coordinate with the committee and Grace to schedule the next suite of interviews.
