# 7/3/25 Meeting Minutes:

### **NFHP Updates**

### **FY25 Project Allocations:**

Grace reminded the Committee that FY25 funds have been allocated to projects as follows:

Project Name	Project Sponsor	Amount

\*Dutch Bill Creek was originally set to receive partial funding, but PSMFC needed to allocate the extra funds from the FYF23 operations budget (~\$60k) in the FY25 budget. The \$60k was originally labeled for operations, so it had to stay within that scope. As such, PSMFC used the \$60k from FY23 operations plus \$45k from the requested \$125k for FY25 operations to create the Forum's FY25 operations budget. This left \$60k from the requested FY25 operations funds available, however, due to typical annual allocations for PSMFC as part of the operations budget (e.g., travel, GIS support) and new federal directives increasing PSMFC's overhead, the actual amount available was ~\$30k. This ~\$30k was then allocated to the Dutch Bill Creek project, allowing it to be fully funded.

# FY26 Proposals:

Grace shared that the FY26 project proposal sponsors have been notified that they were recommended for funding, she is drafting the email to let those who were not recommended for funding. The projects that were recommended for funding are noted below.

# FY27 Timeline Change:

Grace shared that the NFHP Board voted to formally adopt a new RFP timeline due to the slight change in ACE Act verbiage that allows for a quicker timeframe between the RFP and fund distribution. The new timeline, to be implemented for FY27, is as follows:



Grace noted that due to the 'extended' timeframe FHPs have been operating under, there will not be an RFP this year, as the RFP for FY26 was completed in February 2025. The next RFP for FY27 has to occur by the Fall of 2026, but it could occur sooner if the Forum wishes.

It was noted that a shorter timeframe is always preferred and that this might allow folks to count Forum/NFHP funds as soft match for the FRGP.

This information should be added to the funding page on the website, so people are aware that the timeline has shifted.
